Dear Chair Murray, Chair Granger, Vice Chair Collins, and Ranking Member DeLauro,

We write to thank you for the historic increases provided to the Pell Grant in recent years and to urge you to maintain the strong bipartisan support for the program as you work on FY 2024 funding. To that end, as you work within the discretionary spending caps imposed by the Fiscal Responsibility Act, we urge you to ensure that funding dedicated to the Pell Grant program remains within Pell Grants and is not used to fill budget gaps in other programs. If some of the Pell reserve must be spent on other programs, we hope it will remain with federal student aid to help more students from low-income households be able to afford college and receive the economic benefit a postsecondary degree provides.

Pell Grants allow more than six million low- and middle-income students — including nearly 60 percent of Black undergraduates and almost half of Latino undergraduates — to attend college each year, serving a critical boost in affordability for students who would not otherwise be able to attend college. Yet, the current maximum Pell award still covers the lowest share of costs in the program's over 50-year history. Pell Grant recipients today are more than twice as likely as

other students to have student loans, and recipients who borrow graduate with over \$4,500 more debt than their higher income peers.<sup>1</sup>

The Pell Grant reserve should remain available for use in the Pell Grant program now and in the future. According to the Department of Education, 600,000 more students will become eligible for Pell Grants in FY 2025 with the implementation of the FAFSA Simplification Act of 2020. Maintaining the reserve now will ensure funding is available to expand Pell Grants, as Congress intended.

Protecting Pell funding against rescissions is a critical step towards ensuring that the program benefits students, as Congress intended. Thank you for your attention to this important matter.
